# **What is a National Budget?**




A National Budget is a financial plan that outlines a Government's estimated revenues and expenditures for a particular financial year. It serves as a blueprint for the Government's financial activities including its priorities, policies and medium-term economic and fiscal goals.

# **Purpose of this Citizen's Guide**


As per section 13(5)(c) of the Financial Management (Amendment) Act 2021, the Permanent Secretary responsible for Finance must publish:



Fiji's imports are expected to rise steadily from \$7.0 billion in 2024 to \$7.5 billion by 2027, while exports are expected to rise from \$2.6 billion to \$2.9 billion over the same period.

#### **Current Account Balance**



Fiji's current account balance is projected to widen from an estimated \$1.0 billion in 2024 to \$1.2 billion in 2027.



# **Key Revenue Policies**



#### **Strengthening Tax Compliance**

To strengthen tax compliance, all businesses with a turnover of \$50,000 or more will be required to register for the VAT Monitoring System (VMS) starting 1 January 2026. While the VAT registration threshold remains at \$100,000, asset declaration will become mandatory for sole traders.



#### **Departure Tax**

As part of the 2024–2025 National Budget, the departure tax increased from \$140 to \$170 effective 1 August 2024, and will rise further to \$200 from 1 August 2025. This phased increase is expected to generate an additional \$20.0 million in revenue.



#### Fringe Benefits Tax (FBT)

From 1 January 2026, reduced FBT rates will apply to electric vehicles, with rates ranging from \$1,000 to \$2,500 per quarter based on vehicle cost, plus 2% for amounts over \$100,000.



#### **Local Artists Tax Deduction**

The tax deduction for employment of local artists will be expanded to include all businesses that hire artists on a full-time basis. The allowable tax deduction rate will be reduced from 300% to 150%.



#### Tax Incentive for Tour Operators

A new Tax incentive with a 25% investment allowance will be available to new investments made by businesses involved in tour activities. The minimum threshold to qualify for the investment allowance is \$100,000.



#### Tax Free Region (TFR) and Sub-Division of Land Incentives

The TFR will be extended to the Wainadoi region for businesses who invest in activities such as waste management, recycling and renewable energy.

The Sub-Division of Land Incentive will be extended until 31 July 2027.



#### Tax Deductions for Donations

Businesses will receive a 150% tax deduction for donations to accredited start-up support programs, and a 100% deduction for donations to health centers, aged care homes, orphanages, and drug rehabilitation centers.



#### **Renewable Energy Projects**

The tax holiday in relation to the Renewable Energy and Power Cogeneration projects will be increased from 5 years to 10 years.



#### **Carbon Trading**

The income of businesses engaged in carbon trading will be exempted from income tax.

# **Addressing the Cost of Living**



#### **VAT Rate Reduced to 12.5%**

To help reduce the cost of living, the Government will lower the VAT rate from 15% to 12.5% starting 1 August 2025, saving Fijians an estimated \$250 million. The zero-rated VAT on 22 essential items will also continue in FY2025–2026.





#### Fiscal and Excise Duty Changes

To ease cost-of-living pressures and expand consumer choice, the 2025–2026 Budget introduces several duty reductions on common food items.

#### Price Monitoring Enforcement Taskforce

To ensure consumers benefit from tax reductions, a Price Monitoring and Enforcement Taskforce has been established, involving the FCCC, Consumer Council, FRCS, and Ministry of Finance. The Taskforce will monitor prices, address non-compliance, and recommend actions such as price controls, tariff adjustments, and stricter penalties to protect consumer interests.











#### **Opening of New Import Pathways**

The Government will review biosecurity rules to allow food imports from more trusted countries, reducing reliance on limited suppliers and helping lower prices, while maintaining safety standards.



#### Social Welfare and Government Pensioners



A 5% increase in monthly allowance for all social welfare recipients and Government pensioners.



\$4.0M for the reinstated pension payments for pensioners affected by the 2012 pension reforms.



#### **Bus Fare Subsidy**

Government will provide a 10% bus fare subsidy to all commuters from 1 August 2025 to 31 July 2026, costing around \$10.0 million. An additional \$50.0 million is allocated for subsidizing student bus fares (blue card holders - free travel, yellow card holders - 50% subsidy).



#### **Subsidies for Vulnerable Households**


\$25.0 million is also provided for free water, medicine and electricity subsidy for households with a combined income of \$30,000 or less.




#### \$200 Back to School Assistance

A sum of \$40.0 million has been allocated in FY2025-2026.









#### **Civil Servant Pay Rise**

Civil servants will receive an additional 3% pay rise. A sum of \$50.0 million has been allocated in FY2025-2026 for the increase in wages and salaries of civil servants, certain independent institutions and the Fiji Corrections Service.

# **Strengthening Law Enforcement**



#### **Ministry of Policing**

The Government established the Ministry of Policing earlier this year to strengthen public trust in law enforcement. A total of \$3.8 million is allocated to support its operations in the 2025-2026 Budget.



#### **Expanding the Police Force**

To support internal security, the Fiji Police Force has been allocated \$240.3 million in the 2025–2026 Budget, an increase of \$13.5 million from the previous year.

#### **Strengthening Border Protection**

Government remains firmly committed to strengthening Fiji's border security, which is critical for the economy, for sovereignty and the safety of every citizen. New measures will be undertaken to further improve border security:



Construction of a new Container Examination Facility



Expansion of K9 detection capability to Savusavu



Enhanced coastal enforcement capability



Development of a Maritime Single Window



#### **Narcotics Bureau**

To lead Fiji's response to the drug crisis, the Narcotics Bureau under the Ministry of Policing will coordinate efforts to combat drug trafficking and substance abuse. It will serve as the central agency for inter-agency coordination, border enforcement, and intelligence-led operations to dismantle drug networks.



#### **TIN Requirement for Mobile Wallets**

To prevent tax evasion, money laundering, and underground economic activity through digital wallets, all mobile wallet users will be required to register with a Tax Identification Number (TIN) when purchasing new SIM cards. A 6 month transition period will be provided to ensure full compliance.



#### **Asset Declaration Regime**

To build a culture of financial transparency, curb tax evasion, and enhance the integrity of economy, Government will introduce a mandatory Asset Declaration regime for all registered sole traders in Fiji. Effective from 1 January 2026, all sole traders will be required to submit an annual declaration of their assets and liabilities, alongside their income tax returns. This will include movable and immovable assets, loans, and all sources of income.





#### **Measures to Mitigate HIV Epidemic**



# **Key Expenditure Policies**

#### **Education**



#### **Early Childhood Education**

A total of \$32.3 million is allocated for early childhood education in FY2025-2026. The ECE teachers will now be paid on a full-time basis.



#### **Reforming Free Education Grants**

A total of \$65.1 million is allocated for free education grants, which will now become fully flexible and give schools full control over how funds are used.



#### **Primary and Secondary Education**

A total of \$257.9 million is allocated for primary education and \$222.5 million for secondary education.



#### **Removing Restrictions on Fundraising**

In FY2025–2026, the restriction limiting school fundraising to once per year will be removed. Fundraising will become open, voluntary, and flexible.

#### Ministry of Health and Medical Services

- The Ministry of Health has been allocated a sum of \$465.6 million for FY2025-2026.
- \$117.2 million has been allocated for the ongoing operations and maintenance of Lautoka and Ba Hospitals under a Public-Private Partnership (PPP) with Health Care (Fiji) Pte Ltd (HCF).
- \$4.7 million has been allocated for Kidney Dialysis Subsidy, applicable for households earning less than \$30,000.
- \$3.9 million operating grant for Sai Prema Hospital's pediatric cardiac care under a PPP.



#### Renovation of CWM and Health Centres

\$10.8 million has been provided for the redevelopment of CWM Hospital, while \$8.0 million is allocated for the rehabilitation of health centres in Kadavu and Taveuni.



#### 100-bed Super Specialty Hospital

Government of India is providing grant support to construct a 100-bed super specialty hospital in Nasinu.



#### Free Medical Scheme

\$10.0 million allocated in the 2025-2026 Budget to support individuals earning under \$30,000, social welfare pensioners and dialysis patients under the Free Medical Scheme.






#### **Boreholes**

A sum of \$6.5 million is allocated for development of boreholes across the country.



#### Dredging and Clearing of Waterways

A total of \$25.6 million is allocated in FY2025-2026 for river dredging and waterway clearing, including \$3.9 million for the Drainage Board and \$7.3 million for major river dredging across Fiji.

#### **Ministry of Agriculture & Waterways**

The Ministry of Agriculture & Waterways is provided with a budget allocation of \$115.3 million in FY2025-2026. Some major programmes under the Ministry include:

#### Subsidy for Farmers and Leaseholders

Government is introducing a 30 percent lease premium subsidy (up to \$7,500) for farmers and leaseholders earning under \$50,000.




#### **Government Debt**

As of July 2024, Fiji's total government debt stood at \$10.3 billion (79.0% of GDP) and is projected to rise to \$10.8 billion (77.5% of GDP) by July 2025. The debt is made up of 65.0% domestic and 35.0% external borrowing.




# **Debt Servicing**


Debt servicing comprises of principal repayments and interest costs.
